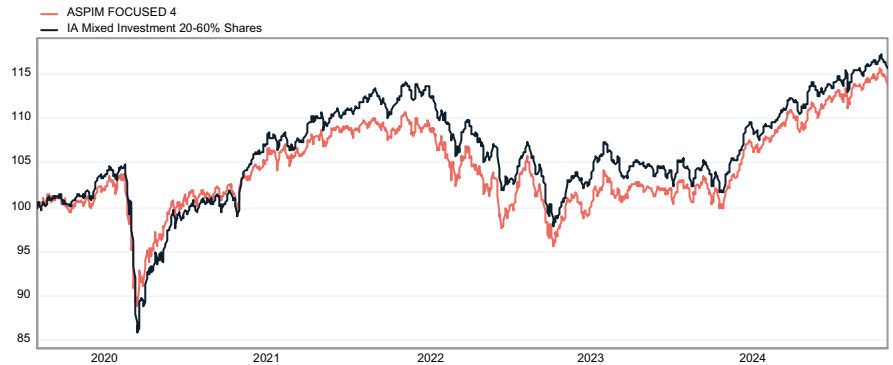

## Performance since inception %



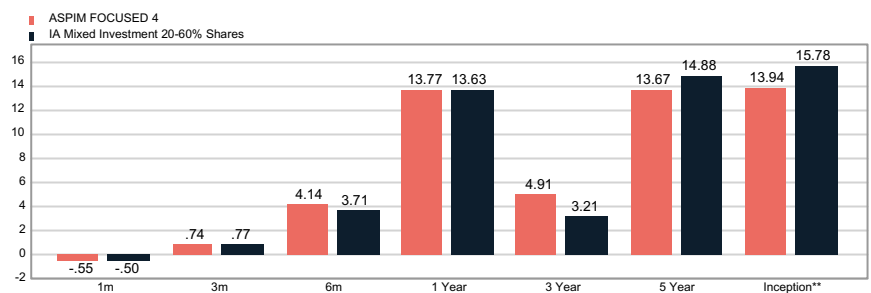

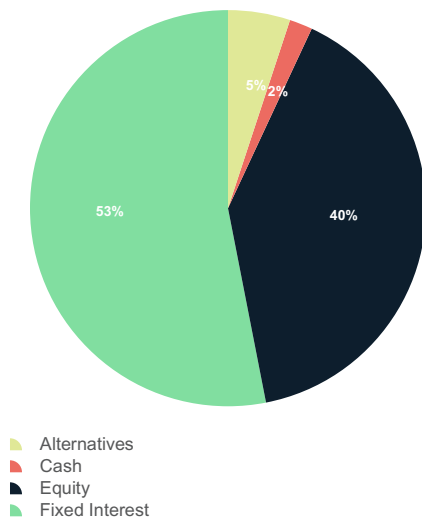

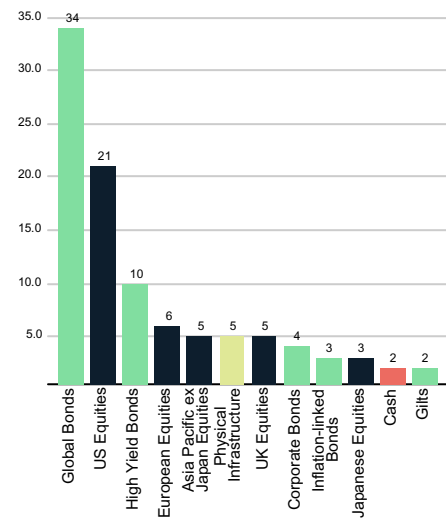
