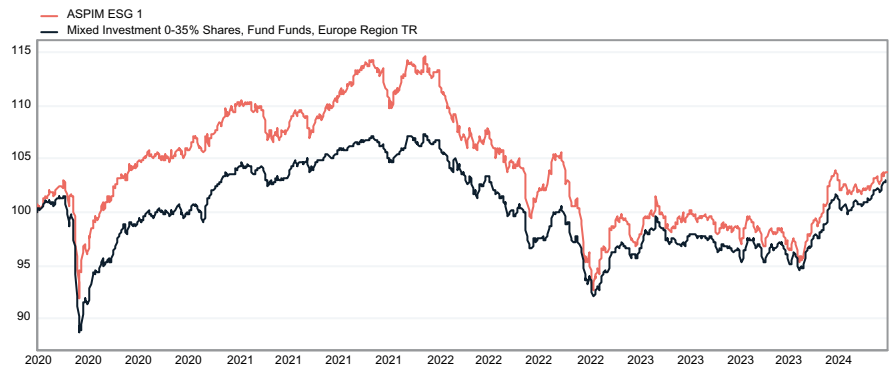

Performance since inception %



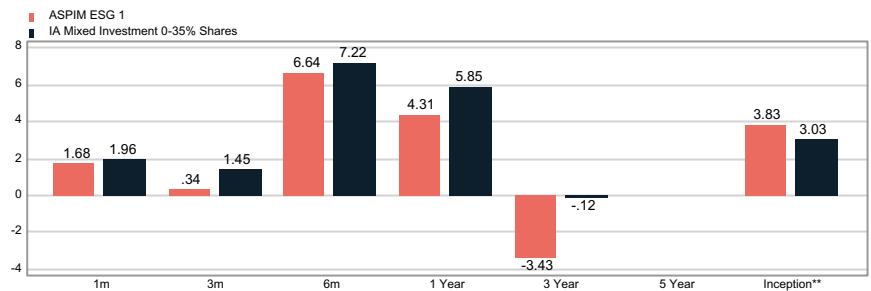

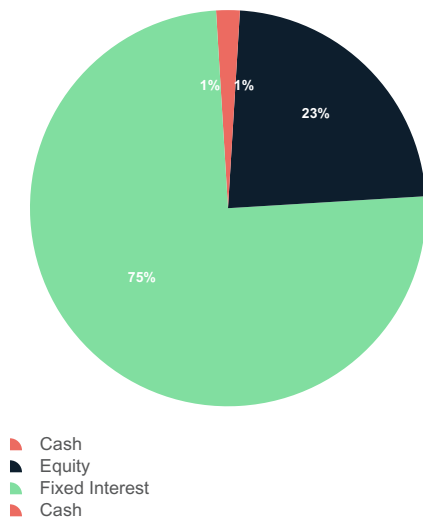

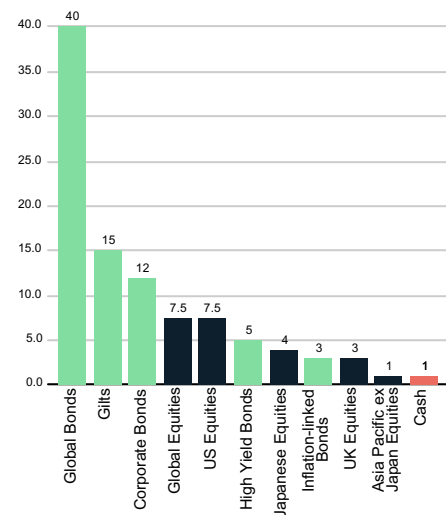
